63/23 To receive an update on the New Town proposals and Local Plan meeting

Cllr Banbridge and Cllr Hoskins had a meeting with George Freeman. Freeman will write to the leader of the council to ask why the 2nd consultation is happening. An update should be given during the next meeting.

All the comments from the first consultation have been captured and reviewed.

Councillors are to encourage people to go online and give their views and complete the short survey. In the initial letter for the parish councils there was a brief mention to try to reach as broad an audience as possible.

64/23 To receive an update on the defibrillator project

Cllr Langford cleared the rubbish in the telephone box and will put a new handle on the door. There is a voucher for the paint. The invoice for the defibrillator is to be paid and wait for next steps.

65/23 Highways matters

a. To receive feedback on research into the possibility of introducing a public footpath along the path of the old road alongside the A1067 between Bintree and Twyford.

Cllr Langford agreed to email Cllr Borrette in regards to the footpath however for the time being the main focus is the defibrillator project being installed and Cllr Langford will pick up the footpath matter at a later date.

b. Village speed limit

A member of the public has queried the speed limit in the village and if it can be reduced to 20 mile an hour.

Cllr bone to forward the application process to the other Cllrs.

A reminder that any accidents need to be reported to help build a case in applying for a reduced speed limit.

c. Grave yard maintenance

M Bozsonyik to email the grounds maintainer for a cut quote for the inside hedges of the church and the graveyard, also a gentle reminder to leave the bulbs until they go brown and not to cut them when they are green.

BRIN could have some funds to go towards the church maintenance.

It was agreed that bulbs would be fine to plant next to the existing bulbs (mostly daffodils) on the bank near the graveyard.
